SOP for Best Teacher Award **Assam down town University**

1. Introduction

The Best Faculty Award, Assam down town University (AdtU) is presented annually to outstanding full-time faculty member in recognition of extraordinary contributions to teaching, research and other academic/ non-academic involvement within the university to recognize the faculty who have contributed significantly to the intellectual life of the AdtU. All regular faculty are eligible for the award who have completed at least one year service in the university. The Best Faculty Award highlights AdtU's commitment to achieve the vision of the university through of teaching, research, innovation and consultancy.

2. Eligibility

Only regular faculty members with at least 1 year of service at AdtU, who currently hold any one of the positions as Assistant Professor, Associate Professor, Professor are eligible for self-nomination.

3. Criteria

Faculty contributions in the following aspects during the last 1 year of service will be taken into account for evaluation.

The evaluation of R&D work of a participant for the award will be based on the following components : publications, patents, externally funded Research Projects, internally seed funded research Projects, Research supervision of PhD and PG students, Industry Institute Interaction and Consultancy Projects, Innovation and other demonstrations
