2. For detailed result students may refer to the e-Mark Sheet in the portal.
3. In the event of any discrepancy detected by a candidate, it should be brought to the notice of the Controller of Examinations within 7 days from the date of declaration of the result.
4. Candidates willing to apply for re-evaluation of the scripts must submit their applications through the ERP concerned within 10 days from the date of declaration of the results.
